Willas-Array set to strengthen its distribution business of Toshiba semiconductor products in Mainland China and Hong Kong by teaming up with Taiwan-based G.M.I Technology Inc.

SINGAPORE – **19 November 2012** – SGX mainboard-listed **Willas-Array Electronics (Holdings) Limited ("Willas-Array"** or "**The Group**"), one of the largest Hong Kong-based distributors of electronics components in the Asia Pacific region, is pleased to announce that it has entered into a joint venture agreement with **G.M.I Technology Inc.** ("**GMI**"), a premier electronics distributor based in Taiwan and listed on the Taiwan Stock Exchange, to strengthen their distribution business of Toshiba products in mainland China and Hong Kong.

Under the agreement, a joint venture company by the name of **GW Electronics Company Limited** has been formed, and the company will be an authorized distributor of Toshiba Semiconductor. The major focus of this new company will be to distribute Toshiba semiconductor products in mainland China and Hong Kong. The operation of the JV is expected to start from early next year.

Commenting on this latest development, Willas-Array Chairman, Mr. Lawrence Leung said: "We are delighted to be expanding our distribution business by teaming up with GMI. As both companies were distributing complementary products under the Toshiba brand name, this collaboration would no doubt aid the Group's further expansion into its main target markets in mainland China and Hong Kong, and will also deepen our market and product knowledge."

Mr. Lewis Lo, G.M.I. Technology President, added, "We are very excited to align with Willas-Array in this venture. In addition to the benefits to our two companies, more importantly this will enable Toshiba to continue their semiconductor business expansion in the very strategic mainland China market. We expect the joint venture to enable all three parties to achieve their aggressive business targets in the years ahead."
